## President's Pilot Box: Gordon Collyer

#### Lenn Airpark and Parks and Recreation.

Usually, I have the freedom to pursue topics of interest to the hobby for the newsletter. If it is about FAA news, at least it is about our hobby. This month while offering some potential good news there are several things that need to be addressed as we start the flying season. These topics, while some are comparatively boring, are important to the club's operations.

As titled, I am going to dig a little into history as it relates to the club and Culpeper Parks and Recreation (P&R). In addition, there may be a fair amount of activity around the Airpark this spring and P&R as asked me to be sure the entire club is up to speed.

1) Relative to history, I will not go back to the 2010 time frame but rather to 2019, when the yearly agreement with the county was modified to be open ended. However, while the terms of the agreement then became fixed without yearly attention required, the character of the agreement did not change. Our arrangement with the county is a "license" to use county property subject to the county's stipulations. It is not a lease which in some ways could provide a level of autonomy over the property depending on the terms of the lease. That is why our license to use the 3+/- acres of the Lenn Airpark has language in it that says in effect we will keep the floors clean (mow) but not move walls (alter the Airpark, pave the runway, etc.) without the county's permission. In the administrative chain of things, P&R has the responsibility for managing the parks, so they are our point of contact. Only 2, I believe, of the 10 county individuals that were involved in the 2019 license agreement are still with Culpeper County.

- 2) Shortly after/during the "COVID" period in a meeting with P&R, we discovered that the county, apparently via P&R's budget situation, had ceased weed control and fertilization (W&F) for the runway. This was a surprise since prior P&R practice had been to treat the runway 2-3 times per season. Per the license, the county owns the land and maintains control of the land, and hence, I believe, if the roof leaks (land management i.e., W&F) that this is the county's role. Keep in mind however that our license can be terminated at the county's discretion.
- 3) In 2023, with P&R's blessing, (you should remember the club's fund raising) the club spread lime and accomplished two W&F applications.
- 4) In the summer of 2024, P&R indicated that the county would resume W&F and other activities where material costs were not involved. The county did aerate the runway in the fall of 2024 but did not perform any W&F activities. It is my understanding that the latter was due to a scope issue with their contractor.
- 5) And here we are. In a meeting I had with the P&R director and P&R's turf contractor on March 25<sup>th</sup>, I was told that P&R would resume W&F this season, level and roll the runway, and re-gravel the parking lot. Some of this work will be P&R activities and some will be P&R contractor efforts. P&R has asked that for W&F spraying days we close the airpark to activities for that day, and for the leveling, rolling and parking lot work we close the airpark to activities for 3-5 days. The club will be notified ahead of time so we are not on site and in the way of equipment, etc. Also note that sometime this summer P&R will be paving up to the fence from the park entrance and access to the Airpark will also be blocked for perhaps 2 days. Schedules, equipment, and weather being what they are, P&R has asked us not to bother work crews about what/how/when etc. they are doing. Any questions along these lines should be referred to the Club President.
- 6) P&R has gotten a complaint that a drone was "following" folks walking on the trails in the park. I have pointed out to P&R that a multicolor drone can be controlled from many locations nearby and that I have personally witnessed two instances of a drone being flown over the park, launched from areas other than the airpark. P&R staff did not retain any details about the event. I have given P&R a set of three questions for staff to ask in the event of future complaints to help identify if anyone was in fact at the Airpark or is a possible witness. I can easily see how a drone flying out to find a downed plane could be miss-identified as "following" someone, especially after the recent New Jersey drone hysteria. However, drone flyers (me included) must be extra cautious about hovering over, or seeming to fly along the trails opposite the runway. We know that the trails are closed when we fly, but any buzzing, hovering or other engagement with anyone on the trails with one of our aircraft is never safe or permitted. Drones in particular because of their flight characteristics can both perform maneuvers that might raise an issue, but also more easily avoid these maneuvers. If verified intentional or repeat events are attributed to a Barnstormer member, then some corrective action from the Board will be indicated.
- 7) P&R's current gate policy has been in effect for about a year and a half. P&R requested I review some gate etiquette with the members, to which I'll add some thought of my own. First and foremost, remember the policy is to lock the gate behind you coming and going. Except for pre-coordinated special events, the gate is not to be left open. I have arrived and found an open gate and in that case the policy is to lock it behind you. P&R has also asked we not feel the need to query anyone driving "inside" the gate regarding their access. The Boy Scouts, for example, can have a lot of folks coming and going, and we need not check on their access, or be responsible for insuring anyone with a car is not behind the locked gate when we leave. I have, and I know others have met folks at the gate coming or going who do not have the lock combination and are asking for access. Our response to this can simply be that the county has limited access due to safety, vandalism, and illicit activities at the north end of the park and that the Barnstormers are among those authorized access. Because of this you can point out that you are obligated to lock the gate. Should they insist on access. Please refer questions about the policy to P&R. Should the conversation escalate, do NOT impede access. When and If, it is possible and safe, lock the

gate; otherwise LEAVE the gate area and contact a club officer as soon as possible and P&R will be informed and then deal with the gate. As the paving up to the gate is completed, I will ask P&R to consider a "Do Not Block Gate" sign which is another concern about parking near the gate, but one that has not yet been an issue.

As I promised, not the usual topics. But I hope some good news regarding the last couple of year's uncertainty about the turf maintenance for the runway.
